Manila Jockey Club, Inc. (the "**Company**") has agreed in principle to lease its horseracing facilities (the "**Subject Facilities**") to Hapi Jockey Club, Inc. ("**HJCI**"). HJCI, a corporation organized by horse owners and grantee of a legislative franchise for horseracing under Republic Act No. 11649, intends to conduct its horse races in the Subject Facilities.

The specific terms and conditions of the lease are still to be determined, and subject to the approval of: (i) the respective Board of Directors of the Company and HJCI, and (ii) the relevant government regulators.

The Company shall disclose the specific terms and conditions of the lease as soon as the definitive agreement/s have been executed by the parties.


